Primary Roles of an AGR Adviser

- **Facilitator:** The Adviser, as a facilitator, encourages and directs a positive flow of communication between individuals leading to the identification of issues, creative options, and decisions, that move the chapter to fulfillment of its objectives.
- **Mentor:** The Adviser, as a mentor, is a role model who advises, supports, encourages, challenges and provides ongoing feedback and friendship that will make positive contributions to the members' personal and professional growth plan.
- **Provider of Continuity:** The Adviser, as a provider of continuity, relays information and knowledge gained from the experiences of undergraduates, alumni, university, and community necessary to perpetuate chapter growth and improvement.
- **Visionary:** The Adviser, as a visionary, anticipates the culture and future needs of the Fraternity, and assists in defining, communicating, revising, and implementing the shared vision.
- **Leader:** The Adviser, as a leader, possesses vision, dedication, strength, integrity, and interpersonal skills to direct the Fraternity through a participative decision making process to achieve goals consistent with the Purpose of Alpha Gamma Rho that maximizes the potential of the Fraternity and each member.
- **Advocate:** The Adviser, as an advocate, will support and promote Alpha Gamma Rho's values, purposes and goals to alumni, campus staff, students, and the community.
